Minutes of Review meeting of DVVNL held at Agra on 03.01.2015

DDUGJY review meeting for the project implemented by Dakshinanchal Vidyut Vitran Nigam Ltd. (DVVNL) in Uttar Pradesh state was chaired by Dr. Dinesh Arora, ED (DDUGJY), REC. Shri Prabhu N. Singh, Managing Director, Dakshinanchal Vidyut Vitran Nigam Ltd. welcomed ED (DDUGJY), GM (DDUGJY-RE) I & II, Zonal Manager, DGM (Tech.) and including all the officials of DVVNL Agra.

Status of 10th Plan Project(s)

It was intimated that all the 20 Project(s) had been closed under RE Component of DDUGJY (erstwhile 10th Plan of RGGVY). Out of 20 Project (s), 11 No. Projects have been financially closed by REC (10% have been released) and balance 09 No. Project could not be financially closed owing to certain non-compliance of closure conditionalities. REC informed that the same had already been requested to Discom. The details of physical & financial closure are as under:

Discom committed that compliance in respect of 09 project(s) would be submitted by 7th Jan, 2015. REC intimated that the final claim(s) would be processed on the basis of compliance.

From the above, it is clear that substantial progress has not been reported in the above project(s) and the slow progress under the project(s) was a serious concern. REC emphasized the need for timely completion of balance works under the ongoing Ph-2 of 11th Plan project(s). REC added that any shortfall or increase (variation in the sanctioned/awarded scope) expected from the project(s) may be intimated so that the proportionate sanctioned infrastructure may be commensurate within the overall limits of sanctioned project cost of the three project(s). REC requested to intimate the details of revised scope in respect of each project (i.e. UEV/EV/BPL and associated infrastructure). Discom informed that the Turnkey Contractor(s) are now performing and that the project(s) shall be completed by them before September 2015. Discom
