The above mentioned B.G. was sent to Indian Bank for confirmation vide this office letter no. 9933 /S.E. (MM)/DVVNL-MM/ RGGVY 12<sup>th</sup> Plan dated 12.12.2014. Branch Manager of the said bank had confirmed vide their e-mail dated 22.12.2014 that this guarantees is not issued from their bank.

From above, it is clear that you have made a fraud and try to mislead the department with corrupt practice. In RGGVY XII plan , it has been mentioned in Standard Bidding Document (SBD) Vol-I, Sec-II, Clause no. 35.0 .....

### 35.0 "Fraud and Corruption

**It is the Employer's policy that requires the Bidders, suppliers and contractors and their subcontractors under the contracts to observe the highest standard of ethics during the procurement and execution of such contracts. In pursuance of this policy, the Employer:**

- (a) defines, for the purpose of this provision, the terms set forth below as follows:
- (i) "fraudulent practice" is any act or omission, including a misrepresentation, that knowingly or recklessly misleads or attempts to mislead, a party to obtain a financial or other benefit or to avoid an obligation;
- (b) will reject a proposal for award if it determines that the bidder recommended for award has, directly or through an agent, engaged in corrupt, fraudulent, collusive, coercive or obstructive practices in competing for the contract in question;"

Keeping in view, the seriousness of the matter, the above mentioned NOA for District Firozabad is hereby cancelled. Other action will be taken separately & you will be informed accordingly.
