The scanned copy of the Demand Draft must be enclosed along with the e-Bids but the original Demand Draft should reach the office of Chief Engineer, EM&RE Wing, JKPDD, Kashmir, Exhibition ground, Srinagar upto 12/05/2016 4:00PM.
3. All the e-Bids must be accompanied by the scanned copy of EMD in the form of CDR/FDR/Bank Guarantee only, pledged to the Chief Accounts Officer , EM&RE Wing, JKPDD, Kashmir. No Interest would be payable on Earnest Money deposited with the Department.
  - a. Hard Copy of original instrument of EMD shall be submitted to the office of the Chief Engineer, EM&RE Wing, JKPDD, Kashmir, Exhibition ground, Srinagar upto 12/05/2016 4:00PM
  - b. The date and time of opening of Financial-Bids shall be notified on Web Site <http://jktenders.gov.in>. This is conveyed to the qualified bidders automatically through an e- mail message on their e-mail address. The Financial-bids shall be opened accordingly online on the same Web Site at the Office of Chief Engineer, EM&RE Wing, JKPDD, Kashmir, Data Center PDD Complex Bemina, Srinagar.
4. Intending bidders are requested to submit their offers along with type test reports from Govt. / NABL accredited laboratories as per terms, conditions, technical specifications and annexures forming part of the tender document.
5. The e-Bids will be electronically opened in the presence of bidder's representatives, who choose to attend at the venue, date and time mentioned in the above table or any subsequent day to the convenience of the Tender Opening Committee. An authority letter of bidder's/OEM representative will be required to be produced.
6. The Department reserves the right to cancel any or all the e-Bids/ the e-Bid process without assigning any reason thereof. The decision of department will be final and binding.
7. In the event of date specified for e-Bids opening/Submission of Hard Copy being declared a holiday for department's office then the due date for opening of e-Bids/ Submission of Hard Copy shall be the following working day at the appointed time and place.
8. All the required documents excluding Price Schedule/BOQ should be uploaded by the e-Bidder electronically in the PDF format, whereas Price Schedule/BOQ should be uploaded electronically in the same BOQ sheet provided with the SBD.
9. To participate in e-bidding process, bidders have to get 'Digital Signature Certificate (DSC)' class III(b) as per Information Technology Act-2000, to participate in online bidding.
10. Ministry of Power (MoP) vide their OM No. 44/30/2015-RE dated 14.08.2015 has formulated two committees to facilitate and handhold States for mobilizing major material/equipment with Standard Technical Specification at competitive rates through a transparent bidding process under DDUGJY. The major high value materials selected under Material Mobilisation are Power Transformer, Distribution Transformer, Conductor, AB Cable& Meters. Committee-A has also finalised Technical Specification of these materials, which are provided in the bidding documents for reference. This material shall

be made available to the partial Turnkey contractor at the Departmental Stores at Anantnag

11. In addition, balance key material viz ST poles, 33 kV C&R Panels, 33 kV VCBs and 11 kV VCB Panel sets shall be arranged through Procurement & Material Management Wing (P&MM) of J&KPDD and made available to the partial turnkey contractor at Central Stores, located at Pampore, Pulwama.
12. Hard copy of Technical and Commercial bid documents (complete) must be delivered to the office of Chief Engineer, EM&RE Wing, JKPDD, Kashmir, Exhibition ground, Srinagar upto 12/05/2016 4:00PM
